CERTIFICATE OF AMENDMENT TO SUPPLEMENTAL DECLARATION OF COVENANTS AND RESTRICTIONS

THE FOLLOWING AMENDMENT is hereby made to the Supplemental Declaration of Covenants and Restrictions dated February 1, 1979, and recorded May 8, 1979, at Reception No. 79040260 in the Jefferson County Clerk and Recorder's Office, said Amendment being made pursuant to Section 2, Article X of said Supplemental Declaration, towit:

The Supplemental Declaration of Covenants and Restrictions are amended by adding the following new Article XI:

ARTICLE XI

RESTRICTIONS UPON COMMON PROPERTY

Section 1. In all cases in which common property adjoins a lot upon which a structure has been erected on the lot line or within any area of the lot in which the fire resistance or opening protection set forth in section 504(b) and Table 5A of the Jefferson County Building Code, as measured at a right angle between the exterior wall and the lot line, is less than the required setback, the following terms and conditions shall apply:

- A. The adjoining common property shall be subject to the entire burden of all setback or distance between structure requirements which are imposed by section 504(b) and Table 5A of the Jefferson County Building Cod.
- B. The adjoining common property which lies within the area subject to the setback or distance between structure requirements described above shall be used only for plaza, park, mall or other permanent open green space and for no other purpose.
